RUN INFORMATION

The race forms a 3.5 mile loop along River's Edge Trail, starting and ending in West Bank Park. The course is mostly flat with slight hills near the bridges and the dog park. The only place you cross the road is near the skate park. View the race map at www.usatf.org. There will be one water station along the way (at the dog park) unless the temperature is below 30. Race will be chip timed.

Runners and walkers are welcome. Please no dogs, bicycles, skates or skateboards. There will be porta-potties available at the start on race day. (and possibly several propane heaters to prevent frostbite if needed!)

REGISTRATION OPTIONS

Cost \$25. After 10/15/17, registration goes up to \$30.

- Online registration is open until 9pm Friday night before the race.
- In person registration is available at the Great Falls Tribune until 5:00pm Friday before the race.
- Race Day registration is available from 7-8:30am Saturday morning at the race start.

PACKET PICKUP

Packet pickup is at the Tribune from 3pm to 5:00pm on Friday or you can pickup your packet at the race start on Race Day between 7am and 8:30am.

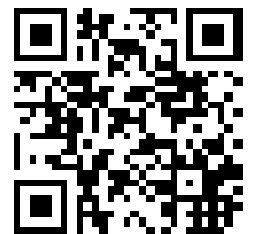
